

The Glens Falls Recreation Commission presents the **Thursday Night Ski Race Series**, assisted by the Friends of Cole's Woods.

When: *4 consecutive Thursdays:* January 19, 26, February 2, 9; Racing begins 6-6:30

Where: Cole's Woods; Start & Finish on field behind Inside Edge

Racing: Skate, Classic, Snowshoe

Distance: 2 km (1 lap) or 4 km (2 laps)

Note: the race course will only take up a portion of the trail system

Start: Rolling Start (Individual), no mass start. Racers will start individually any time between 6 and 6:30 to maintain social distancing.

No Entrance Fee

Signed Waiver Forms required

Timing by Underdog Timing (Bob Underwood)

Number of Participants Expected: 20-40

Once racers complete their race, they must leave the Start & Finish area; they may continue skiing on trails not used for racing.

We will adhere to all public health guidelines and determine each week whether racing will occur*

We will determine each week whether snow conditions are sufficient to allow for racing*

*Weekly determinations will be posted on the Friends of Cole's Woods Facebook page as well as the Friends of Cole's Website (www.friendsofcoleswoods.org) no later than the Wednesday prior to that week's race.
